Swimming Pool Rules and Regulations

Proper swimming attire and swim caps must be worn by all swimmers

1. Use of the pool is at your own risk and the Board of Trustees is not liable for any accidents.
2. Nobody is to swim alone.
3. Children under 12 years **must** be actively supervised by a person at least 18 years old (actively supervised means watching the child at all times and being able to provide immediate assistance).
4. During any session when the pool is in use, there must be at least one person designated as the swimming pool supervisor who will supervise the pool at all times. The number of additional supervisors required will be determined by the number of swimmers. Each key holder is designated as a swimming pool supervisor in relation to the people they bring to the pool.
5. The pool gate shall be securely closed at all times.
6. Behaviour that could be considered dangerous, such as running, pushing, holding under the water and screaming, is prohibited.
7. Take additional care if you have a medical condition such as epilepsy, asthma, diabetes or a heart condition.
8. No running, jumping, or diving into the pool. Avoid holding your breath and swimming long distances underwater. Boogie boards, surf boards, kayaks are not to be used in this pool.
9. No eating, no alcohol or glass containers in or around pool area.
10. Anyone who has had diarrhoea is not permitted to swim for two weeks following last symptoms.

NO NAPPIES! If the pool is contaminated the pool must be shut down immediately and the emergency contact phoned.

On leaving, the pool must be cleaned of leaves and litter with the mesh scoop and two exit doors securely closed.
